#### **CAPITOL HILL UPDATE**

Congress avoided a shutdown Thursday evening extending government funding into March. The plan would uphold the laddered-CR approach by extending some agencies until March 1, including the FDA, and the remaining agencies through March 8. This gives Congress roughly six weeks to finally finalize FY2024 appropriations.

It also gives Congress time to tie loose ends from 2023, including health extenders, but also several expired health programs contained in PEPFAR, PAHPA, and the SUPPORT Act. Several health extenders, including the Community Health Centers, teaching hospitals, diabetes programs, and delayed cuts to Medicaid DSH, are now extended through March 8 under this deal.

While Speaker Johnson initially opposed another CR, he softened his opposition in recent days once it became evident another CR was needed so appropriators could negotiate the final numbers for FY2024. While there were several notable defections among House Republicans, the House overwhelmingly passed the CR to get out of town before the overnight snowstorm in DC.

Advancing this CR also gives time to key health care and tax players on Capitol Hill to jockey for policy priorities, including strengthening the Child Tax Credit, legislation to address drug shortages, mental health, PBMs, hospital and insurer transparency, and other hot topics.

### **ON THE RADAR**

#### Senate Aging Committee Seeks Information from Assisted Living Facilities

Chair Bob Casey (D-PA) of the Senate Special Committee on Aging launched a review of three of the largest assisted living facilities and seeking information on workforce shortages, inadequate care in facilities, and the high-cost of services. The committee will also hold a hearing on January 25, 2024, entitled "Assisted Living Facilities: Understanding Long-Term Care Options for Older Adults." It is not clear if any of the assisted living facilities executives will be testifying, or if they will feature other stakeholders or impacted witnesses.

The investigation stems from Washington Post reporting on dementia-care residents who inadvertently or

unintentionally left their facility undetected and tragically died. The Post found nearly 100 seniors died over the past five years in instances where they left their facility unnoticed or were left unattended outside.

Staffing ratios at such facilities will likely be a key aspect of the committees focus as the Biden Administration considers moving forward with controversial nurse staffing minimums proposed last year. There is bipartisan, bicameral legislation to block HHS from finalizing these rules, but it is possible that this investigation could spur new action.
